I would like to explain briefly the business results of Osaka Gas for the first quarter of the fiscal year ending March 2016.

The first quarter of the fiscal year ending March 2016 resulted in a decrease in net sales and increase in income.

Net sales decreased by 5.7% from the previous year to 341.5 billion yen, due to the fall in gas sales unit price driven by lower LNG prices.

Ordinary income increased by 75.1% from the previous year to 74.1 billion yen, due to the increase in gross profit of gas sales caused by the increase in time-lag profit.

Time-lag profit totaled 41.5 billion yen, up 39.0 billion yen from the previous year.

Gas sales volume for residential use decreased by 3.2% from the previous year to 512 million m³ due to higher air and water temperatures in the reporting period.

Gas sales volume for commercial, public and medical uses increased by 0.9% from the previous year to 302 million m³, due to smooth expansion of new demand.

Regarding industrial use, gas sales volume decreased by 3.9% from the previous year to 978 million m³ due to the fall in capacity utilization of customers.

Investments in the first quarter of the fiscal year totaled 24.6 billion yen, up 4.5 billion yen from the previous year. We decided to participate in a natural gas power generation plant in the U.S.

Please see the financial results for the first quarter of the fiscal year ending March 2016, summarized on page 5.

As shown in the table below, the time-lag profit/loss under the fuel cost adjustment system increased by 39.0 billion yen from the previous year to 41.5 billion yen profit.

As a result, the operating income increased by 33.0 billion yen from the previous year to 72.3 billion yen, and the ordinary income increased by 31.7 billion yen from the previous year to 74.1 billion yen, due mainly to the increase in gross profit.





Risk Factors for Annual Earnings Results Forecast

Atmospheric and water temperatures

A 1 degree Celsius change in atmospheric and water temperatures will affect the residential gas sales volume: increase/decrease of approx. 5% in spring and autumn, approx. 6% in summer, and approx. 4% in winter.

Crude oil prices

 LNG prices are linked to crude oil prices. A +\$1/bbl change in crude oil prices will have an effect of approx. -1.2 billion yen on ordinary profit since the 2nd quarter (Jul. thru. Mar.) of this fiscal year.

Foreign exchange rate

■ LNG prices are affected by fluctuations in the US\$/JPY exchange rate. A +1 yen fluctuation in the US\$/JPY exchange rate will have an effect of approx. -0.7 billion yen on ordinary profit since the 2nd quarter (Jul. thru. Mar.) of this fiscal year.

Materials costs

 Although the fuel cost adjustment system allows us to reflect changes in fuel costs in gas rates in the medium- and long-term, an increase in fuel costs is likely to affect the business results due to a time lag in reflecting cost fluctuations, and also depends on the composition of fuel suppliers.

Interest rate

A 1% change in the interest rate will have an effect of approx. 500 million yen on annual consolidated non-operating expenses.
